Scott Cameron (The Morin-Cameron Group), along with Ann Marton (LEC Environmental), Scott Miccile (Toll Brothers), Brian Madden (LEC Environmental), and Peter Ellison (TEC) met with the Conservation Commission with revised plans, based on the discussions at the last meeting and recent site walk.
