Fund Balances:

- Library Grant: \$11,151.76 Second installment of the State Grant which funds certified municipalities was received.
 - o It is non-discretionary funding to supplement Town budget
 - o It will be used for technology, staff training, and Staff Retention Activities
- Library EDI Gift Fund: \$1,575.46 (includes donations for Tri-Town Pride Parade)
 - Reimbursements to be taken care of which will give a better idea of balance in
 July. 26 tumblers were sold to benefit the Library EDI Gift Fund
- Library Stabilization Fund: \$20,565.57 balance from perpetual trust for 10 Elm property value transfer to library.
 - Town Meeting approval needed to access. Last used for renovations in 2020-2021

Circulation by Fiscal Year

- Given current rate of circulation we will break 60,000 which demonstrates the way the library continues to grow and develop since 2014.
- In September, Year End, and Summer Statistics will be reported to the trustees.
