Mark O'Hara of O'Hara Engineering, advised this is the only location where the septic system can be installed. He worked with the Board of Health to locate the septic system in the best location possible.

**National Grid R.O.W. Between Georgetown Road and Kelsey Road:** The Director advised that National Grid will begin work on the Right of Way on September 20<sup>th</sup>, next Monday. They have provided a set of plans shown at the last meeting and have not requested an Emergency Certification and will be using the exemption for emergency maintenance of utility facilities.

**Carnes, 30 Arrowhead Farms Road, Gas Line Replacement:** National Grid notified the Director that they will be starting work on a gas line replacement at 30 Arrowhead Farms Road. They have not submitted a plan and have not filed for a permit. They are claiming an exemption to repair an existing gas line. The Chair advised that they need to provide a plan. Commissioner Di Luna suggested that they explore the exemption and pre-emption guidelines.

**Town-Owned Conservation Land:** Commissioner Grigg advised that in the West part of town, the ConCom owns a number of properties that are not being cared for.

**Small Oxx Farm Tree Cutting:** Commissioner Grigg brought up the fact that the Conservation Commission voted to allow Smolak to cut down 15 acres of trees three years ago and the lot is still completely bare.

**Bylaw Review:** Commissioner Grigg requested that the Conservation Commission schedule a review of the town's conservation bylaws so that they are more consistently applied.
