#### **OTHER BUSINESS:**

MVLC (Merrimack Valley Library Consortium): K. Bourque

- Macmillan Publishers is prohibiting libraries from purchasing more than one copy of their eBooks for 8 weeks after the titles become available to the public.
  - For the Merrimack Valley Library Consortium, this means only one eBook copy would be available to library users across all of its 36 communities.
  - We will not be able to meet user demand with such a restrictive policy.
  - MVLC has chosen to boycott all Macmillan eBooks that have been released since the embargo was implemented.
  - MVLC will revisit this policy after six months unless Macmillan ends its embargo against library purchases sooner.
  - This boycott does not apply to Macmillan products in other formats, such as print books, audio CD's, and digital audio books, which are not impacted by Macmillan's embargo
- OUTDOOR MOVIE: J. P. Ryan
  - Revisit outdoor movie this year
    - Form a subcommittee
      - Pursue private donors

J. Smallman made a motion seconded by J.P. Ryan to endorse a subcommittee to explore an outdoor event for the summer of 2020. The vote was unanimous.

- REMINDER: J. P. Ryan
  - The proposed reconfiguration of the library will <u>not</u> result in additional taxes for taxpayers
