 - Article 12 to transfer the care, custody, management, and control of 10 Elm Street from the Selectmen for general municipal purposes to the Selectmen for Community Center purposes. This article to be considered if Article 11 fails.

TOWN HALL/LIBRARY FACILITY: L. Shea
