

NEWS FROM THE BAA

Stiles Pond Beach has been open for about a month. Board of Health Update, August 5, 2022

Statewide, new Covid cases decreased slightly last week to 19,619 compared to 20,014 two weeks ago (-2% compared to +3% two weeks' ago).

Last week, new hospitalizations for Covid decreased by 9% as compared to those hospitalized two weeks ago, with those in ICUs increasing from 48 to 57. Of the 560 hospitalized, 334 (60%) were fully vaccinated but still became infected.

Over the past week, there were 8 new cases of Covid-19 in Boxford, as compared to 6 cases two weeks' ago (1,612 total to date).

SELECT BOARD PRESENTATION BOXFORD HOUSING PARTNERSHIP AUGUST 8, 2022

INTRODUCTION

This presentation to the Select Board is a summary of the current activities of the Boxford Housing Partnership.

SENIOR GRANT PROGRAM

The article to establish the Boxford Small Repair Grant Trust (approved at the May Town meeting) has been submitted to the State Legislature for approval. It appears that Senator Tarr has planned to put this on a fast track because, on June 21, 2022, the Joint Committee on Municipalities and Regional Government requested a written testimony for the article by June 24. It was submitted in a timely manner and we are currently waiting for a response on the status.

In preparation for the approval of the article, the Boxford Housing Partnership (BHP) is requesting that the Select Board identify a proposed slate of trustees. There is a significant amount of work that has to be done in setting up the detail steps of the program. This time before the trust is established would allow the proposed trustees to become familiar with the process and provide input on the work done to date. Once the trust is established, the trustees will then have to create the grant agreement that the recipient will be required to sign. At that point, the grant program can go live. We have already received inquiries about the status of the grant program.

BOXFORD COMMONS ARCHITECTURAL STUDY

At the annual Town meeting, the CPC awarded \$34,200 to the BHP to hire an architect for several purposes: to inform the voters of a possible development on Boxford Commons, address uncertainties in that development and identify possible cost-effective designs that fit with Boxford. A development on the community housing portion of Boxford Commons is particularly challenging since Boxford Board of Health septic regulations limit the development to 12 senior units, far less than many developers have interest. If we do not do this study, we may not get a realistic bid from private developers to build and manage such a development. This study will allow the Town to generate a focused RFP for the development and establish reasonable evaluation criteria. Just to be clear, this is not a Town owned and controlled development.

This will be a 2-phase program: The first is a feasibility phase to examine cost effective configurations of housing on a parcel purchased with CPA funds in an Elderly Housing District. During this time, input from Town boards and committees will be solicited, such as the Planning Board and the Historical District Committee. A financial analyst will be hired to examine the numbers and determine if these are consistent with the income levels of eligible residents. This study is only for the construction of the housing units since it is assumed that the development infrastructure (well, septic, road, sidewalks, lighting, landscaping, backup generator, etc.) would be subsidized by CPA funds restricted to community

housing. The financial analysis would determine what additional subsidy (if any) would be needed for the housing.

It is important to perform this financial review since this development is substantially different than standard elderly developments in the area, which are multi story structures with hallways, stairways and elevators. Developers are quick to use a normalized development cost of approximately \$350/ sq. ft., which should not apply to the proposed single story structures. This study will be an educational process both for the Town as well as the developer.

The second phase of the program will be one of public education in preparation for the annual Town meeting. This will be an opportunity to obtain public input on the approach and show the rational for the proposed solutions along with financial backup and possible elevations of a typical design. This work will hopefully facilitate a Town vote to rezone the area as an Elderly Housing District and a vote to transfer the property to the care and custody of the Select Board for development. A draft of the RFP for an architect has been submitted to the Town Administrator for his review.





Hello Leanne.

On behalf of Neurofibromatosis Northeast, I am seeking permission to include Boxford once again on the route for the 11th Annual Coast to the Cure bike ride to benefit Neurofibromatosis Northeast. Coast to the Cure takes place on Saturday, September 10, 2022. The ride starts and finishes at Stage Fort Park in Gloucester. The event consists of three routes (24, 50, and 100 miles) encompassing Boxford and 16 other communities



Hello Matt, The Open Space & Recreation Plan (OS&RP) for Boxford expires in December of 2022. The Select Board typically appoints a committee to undertake the preparation of this document. The most recent members of the OS&RP Committee were Natasha Grigg, Jon Schwartz, and Dennis Pyburn.


The town's Master Plan was last updated in 2008, is effective for 10 years, and is therefore expired. The Master Plan is typically updated with the help of a Master Plan Steering Committee appointed by the Select Board, who in turn may engage a consultant to provide technical assistance in the preparation of the plan. The most recent members of the Master Plan Steering Committee were Holly Langer, Steve Merriam, Clint Condon, Mary Ellen Iorio, Randy Johnson and Mark Mudgett.

If the town wishes to apply for state grants to help fund the purchase of open space, it will have to show that the town's OS&RP and Master Plan are both in effect. There does not currently appear to be a land purchase in contemplation that would rely upon grant funding, however it would seem to be prudent to update the OS&RP and Master Plan in order to preserve the option of doing so. It would seem that the first step in the process of updating these documents is to identify individuals who are willing to serve on the committees. By this email I hope to begin an effort to reconstitute the OS&RP and Master Plan Steering Committees.

Sheriff's Message



Welcome to the 2021 Essex County Sheriff's Department Annual Report.

2021 was a busy year for us and, like the rest of the world, we still had to cope with the COVID-19 pandemic. While we did see some additional cases within our facilities, the pre-cautions and screening/testing protocols we have put in place allowed us to continue our operations and our efforts to better serve those in our custody and the residents of our communities.

We embarked on several new initiatives to help our incarcerated population obtain the necessary supports they need to succeed and

thrive upon release. The cornerstone of this effort is our new Supporting Transitions And Reentry (STAR) program. This community-based corrections program is aimed at keeping people out of jail and from ever returning to custody again.

It was an idea borne out of my days as Lynn Police Chief, where too often I would see the same people cycling in and out of the justice system. I knew these individuals needed help, not only in the jail but back in their communities where we've identified vital supports so critical to their rehabilitation. It was just a matter of connecting them. For two years, a team of the brightest and most creative people on our staff sat down to develop this connection program and built out the plans for it during 2021. In early 2022, we opened STAR offices in both Lynn and Lawrence with the help of \$850,000 in federal funds secured by U.S. Congressman Seth Moulton.

Our initiatives to help those already incarcerated also grew and flourished. One program of note is our Opening Avenues to Reentry Success (OARS). This program dedicates specific housing units to those who want to better themselves and take advantage of the numbers of educational and vocational programs we offer. Those participating get several hours of classroom instruction and group programing daily and then take what they learned back to their housing unit where the individuals continue to learn and teach each other. Some of the programming offered includes HiSET preparation, college level classes from Northern Essex Community College and Merrimack College, and peer tutoring programs. We offer individual certifications in OSHA and ServSafe, as well as training in hardscaping, cable wiring, fiber optics, and so much more.

In conclusion, COVID-19 has had a devasting impact on us all. In December 2021, we lost one of our brothers to the pandemic, Deputy Sheriff Anthony Pasquarello. He was a 15-year veteran of our Department, a loving father, and a dutiful son. He was only 37 when COVID took him from us, and our hearts, prayers and support remain with the Pasquarello family. He will be forever remembered and missed.

I would like to thank our staff for such a wonderful job they do every day. I would also like to thank you for your continued support of our Department. It is an honor to serve you.

He had originally requested Saturday July 2, but then spoke with police Chief Riter and learned that the Planning Committee would prefer the race be held on July 4th to coincide with the parade. The Select Board would like to confirm approval of the plans for the race by the police Chief and the fire Chief and will revisit this proposal on the meeting
- of April 25, 2022.
 - Community Project Funding Request: Congressman Seth Moulton reached out to municipalities organizations in the district to see if there were potential projects to receive earmarks in the next federal fiscal budget. Coogan spoke with a representative from Moulton's office, Kelly Bovio who is our liaison and discussed projects that may fit. The Cole School Project would be a good candidate for funding due to the need for accessibility, ADA compliance, storm water management and traffic safety and circulation. Another candidate could be one of the culverts on the critical culvert list. Congressman Moulton's office recommended no more than two projects and not more than \$1.5 million. Coogan has reached out to the schools so they can start prepping the language to apply and reached out to Chris Olbrot to see which of the culverts would be shovel ready to apply for funding.
