Notes from MCC:

A. Encumbered Administrative Funds

Councils may set aside **up to 5% of their FY22 allocation** for administrative funds. Administrative funds may include: postage, stationary, bank fees, P.O. Box, etc. See P.3 of the LCC Program Guidelines for more information

B. Encumbered funds for BCC-developed Event

- raise awareness of BCC expanding vision
- celebrate FY22 grant awards
- solicit more community input (surveys)
- gather/recognize local "cultural contributors"/artists who enrich the cultural life of Boxford

From FY22 LCC Guidelines

While LCCs may use administrative funds to purchase refreshments for public events, such as grantee receptions, LCCs cannot use administrative funds to purchase food for standard LCC meetings, such as grant cycle voting meetings. Any administrative funds from the prior grant cycle, which have not been spent, or are not encumbered for specific pending expenses, should be treated as unencumbered money and should be regranted. Local Cultural Council Programs. Councils can use up to 20% of their Mass Cultural Council allocation on programs that have been developed by the council that respond to cultural needs in the community that are not being met (see section on Council Programming).
