8. Assistant Field Technician posting and update of the hiring process. The position became vacant due a recent retirement on October 04, 2019 presented by Robyn Januszewski.
9. Wetlands projects presented by William Mehaffey and Katelynn King.
  - a. Amesbury. Brushing of a ditch that runs from the outlet of the pond to the culvert adjacent to Jackson Lumber on Route 110 (information only, no vote for action required).
  - b. Newburyport. Maintenance of storm water retention basin on Bartlett Drive. City of Newburyport DPW will brush basin and haul spoils away (vote for action).
  - c. Nahant. 500' of ditch maintenance at Kelly Greens Golf Course (vote for action).
  - d. Parker River National Wildlife Refuge. Pilot program to reduce the height of 7 ditch plugs to lower the water level in several OMWM sites. Sea level rise is now causing mosquito breeding on and between OMWM sites (vote for action).
  - e. Methuen. Early planning stages. Upcoming site visit, mosquito monitoring during spring and summer. Possibly schedule for next fall or winter (information only, no vote for action required). This item will appear in a future Commission meeting.
