Request for amendments to DEP File #114-1295 Holly Baldassare, 15 Lantern Lane, Boxford

Dear Commission Members:

On May 5, 2020 the Boxford Conservation Commission issued an Order of Conditions for the project at 15 Lantern Lane, Boxford, MA. On behalf of the applicant, Holly Baldassare, we are requesting to amendment the approved plans.

The applicant would like to modify the proposed driveway, utilizing the access road, constructed for the installation of the septic system. The proposed driveway would be paved, and would extend from the street, to the end of the existing driveway, continuing up to the side of the dwelling, utilizing the existing construction access road. Infiltration trenches (2 ft x 2 ft) are proposed on either side of the proposed paved driveway.

The proposed walkway from the dwelling has been shortened to meet the proposed driveway closer to the dwelling. The approved retaining walls in the front yard have been extended as follows: the lowest wall has not changed; the middle wall is approximately 5ft longer and the upper wall is approximately 13ft longer. An additional wall along the front and side of the dwelling, has been added to overcome grade change between the dwelling and proposed driveway. Finally, the erosion control will be modified to add siltation barriers from the street-line, along both sides of the proposed driveway and connect to the approved, existing erosion control, as shown on the enclosed plans.

Please find enclosed a check in the amount of \$400.00, 2 copies of the plans and an updated certified abutters list. I look forward to meeting with the commission to discuss these changes to the approved plans.
