Norse Environmental Services delineated the wetland boundaries. The inground pool and patio are located outside the 75 foot No Structure Zone from the wetland resource area. There will be little to no grading changes associated to this property. There is existing erosion control barrier in place that will need to be maintained. There are no trees to be cut as part of this project.

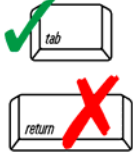
